

Cultural Corner By Matthew Grieco

October brings us Columbus Day, a day for celebration not only for the Columbian Lawyers, but for all Americans, and all the world. For the world would not be what it is had it not been for Columbus. That statement always elicits two questions. Did any Europeans reach America before Columbus? Wouldn't someone else eventually have done so after 1492? The answers are simple, yet of profound importance. To the first question, perhaps, but if anyone did, they didn't stay. To the second, Europe, Africa, Asia, and the Americas, all would have developed differently, in ways we could not possibly know, had Columbus not reached America at the precise time he did.

In last year's October newsletter, we discussed the explorations of Columbus and other Italians, including Marco Polo, Giovanni Caboto (John Cabot), Giovanni da Verrazzano, and Amerigo Vespucci. This year, let us consider the scene that Columbus knew before he left port.

Italy was divided into a number of states: the Kingdom of Naples, the Papal States, the Republics of Florence, Venice, Genoa, Siena, and San Marino, the Duchies of Milan, Savoy, and Ferrara, and the smaller states of Mantua, Lucca, Saluzzo, Asti, and Monteferrato.

Germany was fractured into an even greater number of political entities, although under the overall leadership of the Holy Roman Emperor. Denmark and Lithuania controlled enormous territories, while Muscovy was still relatively small. Spain reconquered the last of its territory from the occupying Moors the same year Columbus sailed. Most importantly, from the Mediterranean perspective, the Ottomans had only recently eradicated the Byzantine Empire and taken over large tracts of the Balkans. The relationship with the Ottomans was a complex one of trading partner and enemy.

The discovery of the New World upset the old political order. A more lasting effect, however, is that the thirst for discovery has remained with us. And whether the exploration has been astronomic or microcosmic, Italians such as Galileo with his telescope, or Malpighi with his microscope, have been at the forefront. Perhaps Columbus's greatest achievement, and greatest gift, was his contagious desire to dream and to dare to explore.
