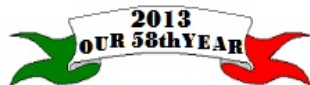

I trust everyone has had a restful summer. We have been hard at work this summer getting ready for our fall schedule.


